

**SCIOTO TOWNSHIP TRUSTEES  
RECORDING OF PROCEEDINGS  
March 4, 2020**

**REGULAR MEETING PROCEEDINGS SUMMARY:**

The trustees of Scioto Township met in regular session, Wednesday, March 4, 2020 at 6:00 pm at the Scioto Township Community Center, 3737 Ostrander Road, Ostrander, Ohio 43061. Board members present were Ralph Moseley and Doug Loudenslager. Also present was Captain Brian Dilley, Zoning Inspector Herb Ligocki, and Sherry Felkner for Fiscal Officer, Kathy Melvin. Others in attendance are listed on the attached sign-in sheet.

The Trustees met to open mowing bids:

- Opening of Bids for Mowing Contract
- Brad Grooms, Zig Zag Lawn Care, provided a bid of \$850 cemetery/ \$400 park
  - o Mowed for the township previously
- Watson's Lawn Care provide a bid of \$710 cemetery/\$1203 park
  - o No representative

- Pony Landscape provided a bid of \$934.00 cemetery/\$846.00 park
  - o No representative
- Mike Kelley provided a bid of \$1000 cemetery/\$550 park
