

**SCIOTO TOWNSHIP TRUSTEES
RECORDING OF PROCEEDINGS
September 15, 2021**

REGULAR MEETING PROCEEDINGS SUMMARY:

The trustees of Scioto Township met in regular session, Wednesday, September 15, 2021 at 5:30 pm in person at the Township Hall. Board members present were Ralph Moseley, Sandra Stults, Doug Loudenslager and Fiscal Officer, Kathy Melvin. Absent were Chief McIntire and Zoning Inspector Herb Ligocki.

PUBLIC COMMENT:

- Doug Riedel, Delaware County Engineer Office, was present to update the township on road projects and the application and process for the stimulus program.
 - Approximate cost of Stover Road guardrail project is \$200,000 and could be eligible for the announced Township funding program.
 - The Stover Road culvert extension and embankment project will be starting in a couple of weeks. Township will begin getting fill dirt into position. Trustee Moseley will coordinate.
 - ARP monies
 - Also discussed the possibility of using ARP funding for a salt barn in the western part of the county. Doug Riedel was requested to provide suggested plans and sizing for a salt barn.
- Trustee Loudenslager moved to have Doug Riedel inquire if the county has plans for a salt barn in the western part of the county. The motion was seconded by Trustee Moseley. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.
- Trustee Loudenslager moved to pursue Township stimulus funding through ODOT to build guardrail on Stover Road, stabilization and pavement replacement of the road along with Trustee Loudenslager be the designated trustee to work with the engineer's office on this project. The motion was seconded by Trustee Moseley. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

APPROVAL OF MINUTES:

Trustee Moseley moved to accept the minutes of the September 1, 2021, as presented by the Fiscal Officer. The motion was seconded by Trustee Loudenslager. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

Trustee Moseley made a motion on September 1 for the purchase of 53 posts and chevron signs not to exceed \$2,000. It was determined this was not enough to cover the costs therefore Trustee Moseley made motion to increase this by \$623.50 to cover the costs. The motion was seconded by Trustee Loudenslager. The roll call vote: Ms. Stults-yes, Mr. Moseley-yes, and Mr. Loudenslager-yes. The motion passed with 3-yes and 0-no votes.

Trustee Loudenslager made a motion to accept the Certificate of Estimated Resources. The motion was seconded by Trustee Moseley. This does not include the \$150,000 ARP monies. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Stults reported the garbage disposal was not working correctly and Amanda Plumbing was called. Trustee Stults will have Amanda Plumbing repair or replace the disposal on September 20 between 8a and 12p.

Trustees stated the front door locks were repaired by Golden Bear.

Trustee Loudenslager made a motion to have carpets and whiteboard cleaned. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Loudenslager made a motion to pay bills. The motion was seconded by Trustee Moseley. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. The motion passed with 3-yes and 0-no votes.

Trustee Moseley made a motion to adjourn. The motion was seconded by Trustee Loudenslager. Roll call vote: Mr. Loudenslager-yes, Mr. Moseley-yes, and Ms. Stults-yes. Motion passed with 3-yes and 0-no votes.
